1.8	Subdivision 1. Appropriation. (a) \$5,000,000 is appropriated from the bond
1.9	proceeds fund to the commissioner of commerce for grants to school districts to pay
1.10	the costs of designing renewable energy projects to generate energy used in public
1.11	K-12 schools. In awarding grants, the commissioner must determine, at a minimum,
